### *Bishop Wilkinson Catholic Education Trust*

#### Requirements

Bishop Wilkinson Catholic Education Trust (BWCET) sought assistance to find a compliant Health and safety, Fire Safety, and Risk Management Software provider for all 48 schools within their Trust. The Trust's aim was to strengthen local relationships, reduce the risk of no-bid responses, whilst also continuing to streamline procurement processes within an effective and compliant route.
