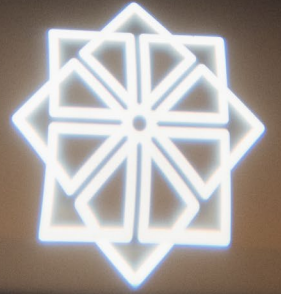

How Agora Legal Works

Clients can choose to operate Agora Legal's FPS via the following options:

1. **Self-serve:** Run your own procurement process with direct access to pre-approved law firms. *(Constellia can also onboard suppliers on your behalf.)*
2. **Managed Service:** Constellia manages direct awards and mini-competitions for you as part of our wrap-around procurement service, saving time and resource.

As per the contract notice, the FPS is open to new entrants at any point during its lifetime, which is until **31st March 2031**.

Service options to support your organisation for competitions:

- **Level 1: Light Touch** – Constellia runs the tender, and bids are passed directly to the organisation.
- **Level 2: Advice** – Constellia runs the tender, advises on shortlisting, specs & criteria; with bids sense-checked before sharing.
- **Level 3: Fully Managed Service** – Constellia runs the tender, drafts documents, supports assessment, manages process; bids sense-checked before sharing.

FAQs

What is a Flexible Purchasing System (FPS)?

FPS is an always-open procurement model allowing law firms to join at any time during its lifetime. It enables quick, cost-effective access to legal services suppliers via **direct awards** and **mini-competitions**.

What is the difference between a Flexible Purchasing System (FPS) and a Dynamic Purchasing System (DPS)?

FPS allows for both **direct awards** and **mini-competitions** to be conducted, making it **more flexible** than DPS, which requires a mini-competition to be run for every procurement.

How Long Does the Call-Off Process Take?

From as little as 24 hours.

Can I Onboard my Own Suppliers?

Yes, absolutely. Simply provide us with the supplier's contact details, and we will take care of the rest.

What are the Fees?

3% of the invoice value for every call-off contract put in place; however, this is paid by suppliers to Constellia.
